<u>Diocesan Council - Lay (Lay elect one for 4 Year Term):</u>

Tawnie Williams (Emmanuel, Emporium) I feel called to be a member of Diocesan Council because of my desire to be of use. I have been a member of Emmanuel, Emporium for 15 years. During that time I have been a member of Vestry for 4 terms and have served as treasurer since 2012. I have also been a member of the choir and serve as an acolyte. The Rev. Stacey Fussell (Ascension, Bradford) I have been ordained for over 24 years and have now spent half of my ordained life in NWPA. After serving as an Associate then Interim Rector at a parish and Church Planter and Vicar of a mission church in the Diocese of Texas, I answered the call to be Rector of Church of the Ascension in Bradford. In the past 12 years we have seen strong growth and have begun several new ministries, including a mobile food pantry, a weekly lunch ministry, regular worship services at the University of Pittsburgh-Bradford and a Preschool. I currently serve as President of the Bradford Area Ministerium, Dean of the NE Deanery and President of the NWPA Standing Committee. I have served the wider church as a Reader for the General Ordination Exam, a member of the task force that crafted the liturgies for Church Planting found in the Book of Occasional Services and the head of Secretariat Sections at the Lambeth Conferences

of 1998 and 2008. I proudly represented the Diocese of NWPA as a Clergy Deputy to General Convention in 2018 and 2022. I believe my broad experiences in the diocese and wider church will enable me to bring strong insights and commitment to serving as a Deputy again in 2024.



The Very Rev. Melinda Hall (Cathedral of St. Paul, Erie) Having attended General Convention in 2022, even though it was irregular, I have an understanding of how this legislative process works and believe this experience makes me a good candidate for deputy. I also understand that I represent the entire diocese; having served rural congregations and now in an urban setting, I have experience in a variety of ministry settings that enlarge my perspective.
